In the field of anti monopoly and anti unfair competition, Lawyer Jiang has provided legal services for domestic mergers and acquisitions of multiple multinational companies and domestic enterprises, as well as for anti monopoly declaration of business concentration in cross-border mergers and acquisitions, helping relevant enterprises successfully pass the anti monopoly review of business concentration. Jiang Liyong has also acted as an agent in several anti-dumping and countervailing investigations involving imports and exports.
