- Acting for the plaintiff Taizhou Liangjie Dredging Engineering Co., Ltd. v. the defendant Tianjin Jinsheng Xinyuan Construction Engineering Co., Ltd. in the maritime and maritime disputes case.

### Settlement of civil and commercial disputes

- The compensation case of the "Consumer Rights Protection Law" applied to the sale contract dispute between the plaintiff Wang Changjin and the defendant Yao Youfeng.
- The labor contract dispute between the acting appellant Xu Changqing and the appellee Jiangxi Qixin Group Co., Ltd. was remanded for retrial.
- Acting for the defendant Zhou Qiulan in the unjust enrichment dispute, the plaintiff Zhang Ling's lawsuit was dismissed.
- Acting for the defendant Ma Chuanjin in the dispute over the sales contract, the plaintiff Hua'an Kangda Feed Co., Ltd. was dismissed.

### Criminal action

- Shen Zhibo's case of not identifying wrongdoing in the crime of seeking provocation and causing trouble was included in the "Collection of Typical Criminal Cases in Jiangsu Province".

- Lin Ning is suspected of the cancellation of the fraud case.
- Peng Ruwei is suspected of the cancellation of the fraud case.
- Tang Yajun is suspected of rape and disapproval of arrest.
- Ji Yong is suspected of not prosecuting the crime of falsely issuing value-added tax invoices.
- Jiangsu Jinyan Transportation Engineering Co., Ltd. is suspected of colluding in the bidding crime compliance non prosecution case.
- Han Weiqi is suspected of theft without prosecution.
- Wu Zhiyong refused to execute the court's judgment, ruled that the crime was remanded for retrial in the second instance, and was exempted from criminal punishment in the retrial.
- Yangzhou Baolai Technology Industry Co., Ltd. is exempt from criminal punishment for the crime of polluting the environment.
- Zhu Qidong's crime of illegal detention applies to the case of suspension of sentence.
- "Xu Wenming's case of mitigated punishment for the crime of dereliction of duty."
- Yu Shanning's crime of collusion in bidding is a single penalty case.
- Zhang Yin's conviction for the crime of drug trafficking only identified a 20% reduction in the amount charged.
- The judgment on the crime of falsely issuing value-added tax invoices in Xinzhuan only identified a lighter punishment of 30% of the amount charged.
- Yao Ming loves to change the sentence of the second instance of the crime of endangering public security by other methods.
- The second instance of the crime of illegal business operation in the sea was revised.
- Yu Huaitao's contract fraud and loan fraud crimes were remanded for retrial and mitigated punishment cases in the second trial.
- Zhao Jianchun was remanded for intentional homicide.
- Cheng Qizheng's robbery case was retried and sentenced.
- Zhao Jianchun's death penalty review application for robbery was submitted to the Supreme Procuratorate for legal supervision.
